

TERMS OF SHIPMENT FOR DELIVERABLE YOGA PRODUCTS/BOOKS

The shipping costs are displayed during the ordering process in the basket or can be calculated in the field "Calculate Shipping". So it is possible to see the shipping costs prior to the conclusion of the order.

The shipment of our products will be launched after receipt of the correct payment in CHF, usually within the following 2-3 days. **NOTE:** *International bank payments shall be made in CHF (not in the local currency). All bank charges & currency exchange fees shall be borne by the customer. Thank you very much.*

We use Swiss Post AG as a delivery agent. The shipping costs are calculated depending on weight and destination, approx. based on the applicable rates of the delivery agent.

For consignments which will not be sent by registered post or against Signature, Sundari Yoga takes no liability. For certain delivery options below there is a liability for loss or damage granted by Swiss Post according to their GTC. Specific delivery times and conditions can also be found online at post.ch/preise-berechnen.

1. Shipping within Switzerland and Liechtenstein

B-Post Letter (1 book): Prices by weight: CHF 4.00 (501g - 1000g) | approx. 2-3 working days

PostPac Economy: prices by weight: CHF 9.00 (1-2 kg), CHF 11.00 (2-5 kg), CHF 12.00 (5-10 kg), CHF 17.00 (10-20 kg) | approx. 2-3 working days. Delivery by Swiss Post (PostPac Economy - Signature). Signature = reception must be confirmed by the addressee with a signature. In case of absence the delivery can be picked up at the nearest post office.

2. Deliveries abroad (Europe)

We accept orders from the following European countries: Germany, Austria, Belgium, Denmark, Finland, France, Great Britain, Italy, Luxembourg, Monaco, Netherlands, Norway, Portugal, Sweden, Spain and the Vatican State.

Economy-Post Letter (1 book): Prices by weight: CHF 10.00 (501g - 1000g) / approx 4-12 working days.

Prices for mailing parcels depend on weight and destination and are approx. based on the current rates of the delivery agent. They can be calculated in the cart (Section: "calculate shipping") prior to the conclusion of the order. The following shipping methods are possible, depending on shipment weight:

Minipac International Economy (up to 2kg): about 4-12 working days | not registered | no liability in case of loss or damage.

PostPac International Economy (> 2kg): about 4-15 working days | not registered | Liability in case of loss or damage by Swiss Post AG according to GTC, up to CHF 1,000.

Minipac International Priority (up to 2kg): about 2-4 working days | registered post (delivery against signature) | Liability in case of loss or damage by Swiss Post AG according to GTC, up to CHF 150.-.

PostPac International Priority (> 2kg): about 3-5 working days | not registered | Liability in case of loss or damage by Swiss Post AG according to GTC, up to CHF 1,000.

For deliveries abroad additional country-specific duties, taxes and fees may apply, which shall be borne by the customer. The amount of the fees depends on the country of delivery. Please check for these fees at your customs office on site. Import duties are not shipping costs.
